Definitions:

Open Seat = Available due to term completion

Vacancy = Available due to resignation, disqualification, or removal

Procedures for filling open seats and vacancies:

1. Senate. All senate seats are nominated and elected by the faculty according to rules set by the Senate. Vacancies can be temporarily filled by the Executive Committee and expire at the next regular or special election. Senators on sabbatical may request that their seat be declared temporarily vacant; sabbatical replacement seats, appointed by the Senate, expire upon completion of the elected Senator's sabbatical.
2. Councils and Committees: Elected Seats (other than UPC and APERC). Open seats, and vacancies occurring after April 1, are filled during the regular election in May. Any seats not filled by the election are declared vacant. Vacancies occurring between the regular election and March 31 can be permanently filled by Senate appointment on recommendation of the Executive Committee.
3. Councils and Committees: Appointed Seats. Filled by the appointing authority at any time. Senate appointments are made on recommendation of the Executive Committee.
4. University Personnel Committee (UPC). Open seats are filled as per the agreement.
5. Academic Program Elimination Committee (APERC). Open seats are filled during the regular election in May. Vacancies are filled by appointment of the Senate president after October 15.

UNIVERSITY FACULTY SENATE

Senior shared governance body includes elected Unit A representatives from the four colleges, University Library, and *emeriti* to staggered two-year terms and one senior-status Unit B faculty member elected for one year by the Unit B faculty at-large from the colleges/University Library on rotation (Bylaws III-1; Standing Rules II-5). Meets monthly during the fall and spring semesters, usually on the third Thursday at 1pm (Standing Rules I-10), and requires additional service on at least one Senate Committee or University Council (Bylaws III-8). President must be tenured (Bylaws V-1). For more information, contact the Senate President.
