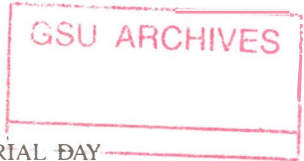

**SBDC AWARDED A \$70,000 GRANT** . . . **MUSIC RECITAL HALL NAMED IN HONOR OF DR. ALFONSO SHERMAN** . . . The Board of Governors of State Colleges and Universities has agreed to name the Music Recital Hall at GSU in honor of Alfonso Sherman, the first dean of the College of Cultural Studies.

Sherman died of cancer in 1980. He joined the GSU faculty in September 1970 with 20 years of previous academic experience from positions he'd held at Southern University in Baton Rouge, La., Washington State University, and South Carolina State College. At GSU Sherman helped formulate the first fine arts program and staffed it with outstanding faculty. "In the course of the university's development he was instrumental in the conception, design and furnishing of the Music Recital Hall, the facility that is to be renamed in his honor," **President Leo Goodman-Malamuth** notes.

"Naming the Music Recital Hall after him is an appropriate honor for an individual who contributed so much to the university and to its fine arts programs in particular."



**WESTON SHOW OPENS AT INFINITY GALLERY.** . . Black and white photographs by **Brett Weston** will be on exhibit during May in the GSU Infinity Gallery. The 23 works, part of the permanent collection at GSU, depict nature—specifically the untouched, Rousseauistic world on which civilization has not yet impinged.

The Weston show will have its opening with a 5 p.m. reception May 8 in the gallery on the second floor of the GSU building. Gallery hours are 3 to 7 p.m., Mondays through Fridays. The show will continue through May 29.

**PERSONNEL POSTSCRIPT.** . . The Tax Reform Act of 1986 requires all employees to submit a 1987 Form W-4 or W-4A to their employer before October 1987. Dear Friends and Colleagues:

In my most recent Report to the Region I have listed a number of reasons why it is important that the State of Illinois increase funding for education. In so doing, I have explained the need for a tax increase in order to improve the financing of education in our state. If you have not read the Report, I urge you to do so as soon as it is convenient.

As part of the effort to increase the number of dollars which our state invests in education, I urge you to write to our area legislators to encourage them to support the increased funding for education which is contained in Governor James Thompson's proposal for tax changes. I realize, of course, that tax increases are not popular; however, the future health of our educational systems demand that all citizens of our state make necessary commitments today. I hope you will agree with me in this assessment.

On the reverse are the names and addresses of several legislators from our region. Simply write them that "I support Governor Thompson's proposed tax increase as a means of improving funding for education," sign your name and address, and mail as soon as possible. Your effort in this regard is very important to the future of Governors State University, and to all other public educational institutions in Illinois.
