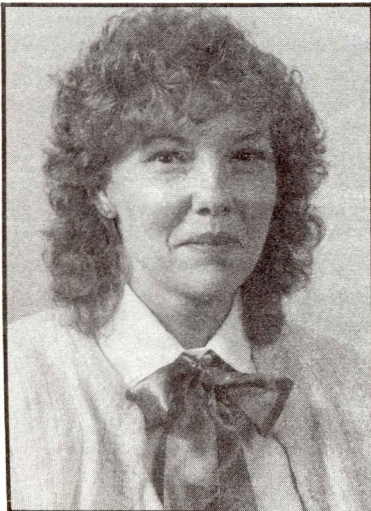

GSU PRESIDENT MEETS WITH LEGISLATORS ABOUT TAX INCREASE... **Dr. Leo Goodman-Malamuth** invited south metropolitan area members of the General Assembly to a June 8 meeting at the university to discuss proposed legislation involving a tax increase to meet the needs of higher education. **Senators William Mahar Jr., Margaret Smith, Howard Brookins** and **Rep. Terry Steczo** attended. The university was represented by **Dr. Virginio Piucci (A&P)**, **John Ostenburg (UR)**, **Dr. John Lowe (CHP)**, **Dr. Larry Freeman (CE)**, **Dr. Mel Muchnik**, **Janice Schultz (PO)** and **Bill Dodd (UA)**.


Dr. Goodman-Malamuth presented the university's need for additional state support and expressed strong misgivings about being asked to administer the fastest growing state university in Illinois with the 2 percent increase in funding projected for FY88. Drs. Freeman, Lowe and Muchnik each presented, from their perspectives, their requirements for additional support. Consensus among legislators present seemed to be that they would support a tax increase only if the bill guaranteed that a substantial portion of the funds would go to higher education.

NOTES FROM JUNE 1987 BOARD MEETING

Board Appoints President--The Board of Governors of State Colleges and Universities (BOG) selected Dr. Ralph H. Wagoner as the ninth President of Western Illinois University (WIU), effective August 1, 1987. Wagoner replaces Dr. Leslie F. Malpass, who will retire July 31, after serving 12 years as WIU's president. Malpass is currently the longest serving Illinois public university president.

Wagoner, who has been at WIU since 1977, previously served as WIU's Vice President for Public Affairs and Development, Executive Officer of the Western Illinois University Foundation, and a Professor of Education.

Before coming to Western, Wagoner held positions at Drake University as an Associate Professor of Education; American Council on Education Administration Intern, Office of the President; Assistant to the President; and Assistant to the President and Director of Development from 1970-1977. He and his wife Susie have two children.

Wagoner was among three final candidates recommended to the Board by BOG Chancellor Thomas D. Layzell for final interviews on June 18. Layzell was assisted in the process by a Campus Advisory Committee chaired by WIU Professor Dr. John Werner. The eight-month long process involved the screening of 125 candidates for the position.

Board Approves Insurance Contract-- Utilizing the Illinois Educational Consortium, the four Illinois state university systems bid for property insurance under the name of the Illinois University Systems Insurance Association. Chancellor Layzell stated this was the first time the four university systems have bid insurance jointly. Plans call for exploring the possibility of jointly bidding liability insurance. Joint bidding for the contract resulted in a \$337,483 premium reduction, which is an 86% savings for the BOG from the 1986 contract. Total savings for all four systems is \$957,064.

Employee Assistance Program Celebrates First Year-- Following favorable review by the Board, the contract with Associates for Progressive Social Services, Inc. (A.P.S.S.) has been renewed. The A.P.S.S. staffs the Employee Assistance Program, which completed its first year of operation June 30, 1987. The Program was initiated to help employees of the five BOG universities, the System Office, and the Cooperative Computer Center, with alcohol and drug abuse, financial, and personal problems. 106 employees utilized the program during its first nine months, and several employee orientation and supervisory training sessions were held at each university.

Academic Program Matters-- The Board approved a request from Governors State University (GSU) to add a minor in Alcoholism and Drug Abuse Sciences. The minor makes the Alcoholism and Drug Abuse Sciences coursework more accessible to undergraduates in other degree programs.

The Board also approved four academic program requests from WIU. The name of the M.A. in Communication Arts and Sciences was changed to the M.A.

in Public Communication and Broadcasting. Parts of the existing degree program dealing with speech communication and broadcasting will be retained under the new name and a new degree program will be developed from the remainder.

The name of the Institute for Regional, Rural, and Community Studies was changed to the Institute for Rural Studies. The name change is the result of the recent approval for the newly-approved Illinois Institute for Rural Affairs at Western.

The request to reorganize the Bachelor of Business program into two options -- an Administrative Office Systems option and a Management Information Systems option -- was approved.

The Board approved WIU's request to form an Interdisciplinary minor in Urban and Community Studies. The minor will provide students with an introduction to the development of an urban concept of community in society.

Board Adopts Resolution Praising Student Board Members-- The Board adopted a resolution thanking the student Board members who "have served...with dedication and distinction...assisted the Board in its deliberations and decisions by presenting their views in a thoughtful and articulate manner and ... not only addressed the concerns of their separate universities but also have contributed measurably to the enhancement of higher education throughout the state."

Student Board members who served in 1986-87: Eddie Kemp, Chicago, Chicago State University (CSU); Michael Ashack, Homewood, Eastern Illinois University (EIU); Larry Lulay, Chicago Heights, GSU; Tom Shaw, Chicago, Northeastern Illinois University; and Steven Eckhart, Lake Villa, WIU.

The newly-elected student Board members will take office at the July Board meeting.

Legislative Update-- The full Senate passed the BOG appropriations bill, Senate Bill 284, in floor action May 18. After a hearing before the House Appropriations II Committee on June 17, the full House passed our amended Appropriations bill. The Senate then concurred on these amendments June 28, thus sending our bill to Governor Thompson's desk awaiting further action on his part. All indications are that significant reductions by the Governor are to be expected.

Progress Report on Provisional Admission Policies in the BOG System-- Course-specific admission requirements approved by the IBHE will become effective for all Illinois four-year public universities and community colleges Fall 1993. Course-specific admission requirements for BOG universities admitting freshmen will become effective Fall 1988. Since, in most cases, BOG admission requirements are less stringent than those established by the IBHE, this intermediate step provides an opportunity for BOG universities to assess the impact of their own admission requirements prior to moving to the more restrictive IBHE requirements.
