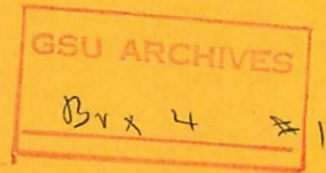

NEWS FROM SPRINGFIELD...Retirement Legislation Passed. The Governor recently signed the following retirement actions:

To increase maximum survivorship benefits to \$500 a month (formerly \$350) if one has more than one dependent; and to \$300 a month if only one dependent. The other provisions of these benefits remain the same.

To allow purchase of retirement credit for half-time public service in Illinois but only for full-time public service outside Illinois.

To add a retired person (retiree or annuitant) or a participant (presently employed person) to the Board of Trustees of the State Universities Retirement System.

To provide a minimum benefit annuity to those long retired who had long service, a help to about one thousand annuitants.

The Governor vetoed House Bill 330 which would have permitted a refund to persons who paid for retirement credits at the 10% rate when buying in their military service credit just before the 8% rate was adopted.

Federal House of Representatives Bill 9155 now being acted on in Washington, D.C., intends to make applicable to State and local governmental retirement plans the requirements for adequate funding that were imposed upon the private sector in the federal Pension Reform Bill of 1974. You are urgently requested to write to your representatives in Congress, both Houses, to support this Bill. ATTENTION FACULTY MEMBERS...The deadline for submitting nominating petitions for the two open positions on the Council of Faculties is Wednesday, October 29. So far only one petition has been picked up from the Office of University Relations!

PROGRESS REPORT...The Search Committee for the University Vice-President, Academic Affairs, has set December 19, 1975, as closing date for applications, and will be selecting candidates for final interviews by January 15, 1976.

The Committee's advertising and announcement programs are in operation and nominations and applications are already being processed. Chairpersons Peter Colby and Roger Oden encourage further recommendations of candidates from the GSU community.

"THE RIGHTS OF SENIOR CITIZENS"...will be discussed Wednesday, Oct. 29, at the "Theology for Lunch" series. The ecumenical Campus Ministries council is sponsor of the "bring your own brown-bag lunch" sessions in Room D1120 at Noon.

FREE LECTURE...Judge William Sylvester White, presiding judge of the juvenile division of the Circuit Court of Cook County, will speak Oct. 29 at 7 p.m. in the CCC on "The Role of the Judge Counseling Juvenile Offenders." Judge White's court, the first, and one of the largest juvenile courts in the country, consists of 11 judges and 250 probation officers. Judge White has presided over the juvenile division since 1968, previously serving in the law, criminal, and divorce divisions of the Circuit Court of Cook County. He is secretary of the National Council of Juvenile Court Judges and chairman of its accreditation committee, and chairman of the Illinois Judicial conference's juvenile problems committee.

THE CHANGING OF THE CARDS...The end of Block 2 and the beginning of Block 3 calls for a change in the parking cards. On Wednesday morning, October 29, the parking gates will accept only the No. 12 Blue Card and the No. 13 Tan Card. The No. 11 White Card will no longer be valid.

DID YOU KNOW...that a study on the accessibility of the food stamp program in Will County by GSU students is being considered by the federal government. Cong. George M. O'Brien received the study by graduate students from Dr. Michael D. Lewis and forwarded it to both the House Agriculture Committee and the Department of Agriculture. ..A study conducted by the U. of N. Dakota found that for each dollar N. Dakota appropriated to public higher education in 1973-74, colleges and universities returned \$2.10 to the economy of the state through college-related spending. The report concluded that higher education is "an important industry" to N. Dakota, generating jobs on the campuses and income for state business and industry, which in turn generates more jobs in the state... that new data from the Bureau of the Census confirms a trend suspected by many educators concerned with rising tuitions: the percentage of working-class and middle-income students attending colleges have declined in recent years. Data shows that among families in the \$10-\$15,000 a year income bracket, college attendance fell by 9% from 1969-1973; in the \$7,500-\$10,000 bracket, a 7.1% decline. The decline is considerably less for families below \$7,500 and for those above \$15,000.

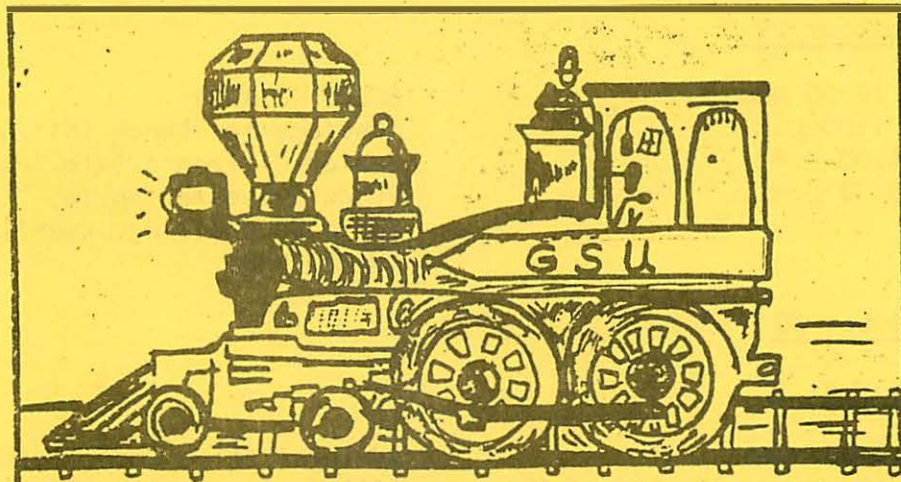
MORE JAZZ...Jazz poet Ted Joans will read his poetry to a background of jazz music in free performances Oct. 28 and 29 at Kennedy-King College in Chicago. The readings, open to the public, are scheduled for Tues. evening at 7:30 p.m. and Wed. morning at 11:00 in the Music Studio (Room 3157) of the college. Joans, a painter and musician as well as poet, published his first book of poetry, "Funky Jazz Poems," in 1959. Both his poetry and music brought him into close association with some of America's greatest jazz musicians: Charlie Parker, Miles Davis, Thelonius Monk and Dizzy Gillespie. Joans' appearance is the first of a series of public convocations to be given by Kennedy-King College.
