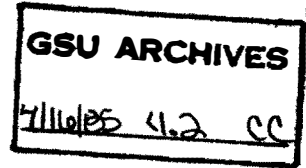

GSU STRING QUARTET OPEN THIRD SEASON

A program of music by Debussy, Mendelssohn and Arriaga will open the third musical season for the GSU String Quartet. The concert is free, and will take place on October 4 at 4:00 p.m. in the Music Recital Hall.

The ensemble was organized in December, 1979, by first violinist and leader, Dr. Francois D'Albert, artist-in-residence and community professor of music here.

The quartet includes Elmer Rosen, second violin; Robert W. Shamo Viola; and Alan Rostoker, cello. Each year since its founding, the quartet has played at least three programs on campus and several others throughout the Chicago area. This year, the members will also conduct master classes in string quartet chamber music at GSU.

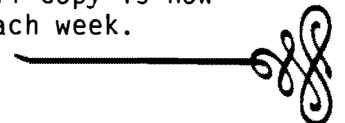
The high school debate topic for 1981-'82 is "Educational Standards," says John Morton, director of OEE.

LECTURE SERIES ON HOSPITALS--LEGAL AND FINANCIAL PROBLEMS

Jerry Lambert, attorney from Flossmoor, was the first speaker in the 7th Annual Health Services Administration Lecture Series at Governors State University on September 23. Lambert addressed the critical issues of risk management in hospitals and the legal liability of health professionals.

The increased concern over malpractice and the containment of health care costs have made it important for hospitals to develop management programs to reduce risks while providing quality care.

Other speakers in this year's lecture series will address such topics as Planning, Budgeting and Control Systems for Hospitals, Financial Management of Hospitals and Hospital Administration.
