Approval of Minutes:

Approval of CS Meeting Minutes for September– It was moved by Sandi Kawanna to accept the September minutes as written and seconded by Shelina Jenkins. Minutes were approved by unanimous vote.

Committee Reports:

1. **Governance Committee** – No report. Scott Smith nominates Shawn Jones for the Senate for the remainder of the FY 2014 term. Lauren Esolato seconded the nomination. All in favor by unanimous voice vote.
2. **Employee of the Month** - Four nominations were turned in this month. The Committee voted; they have not heard anything as of today from HR.
